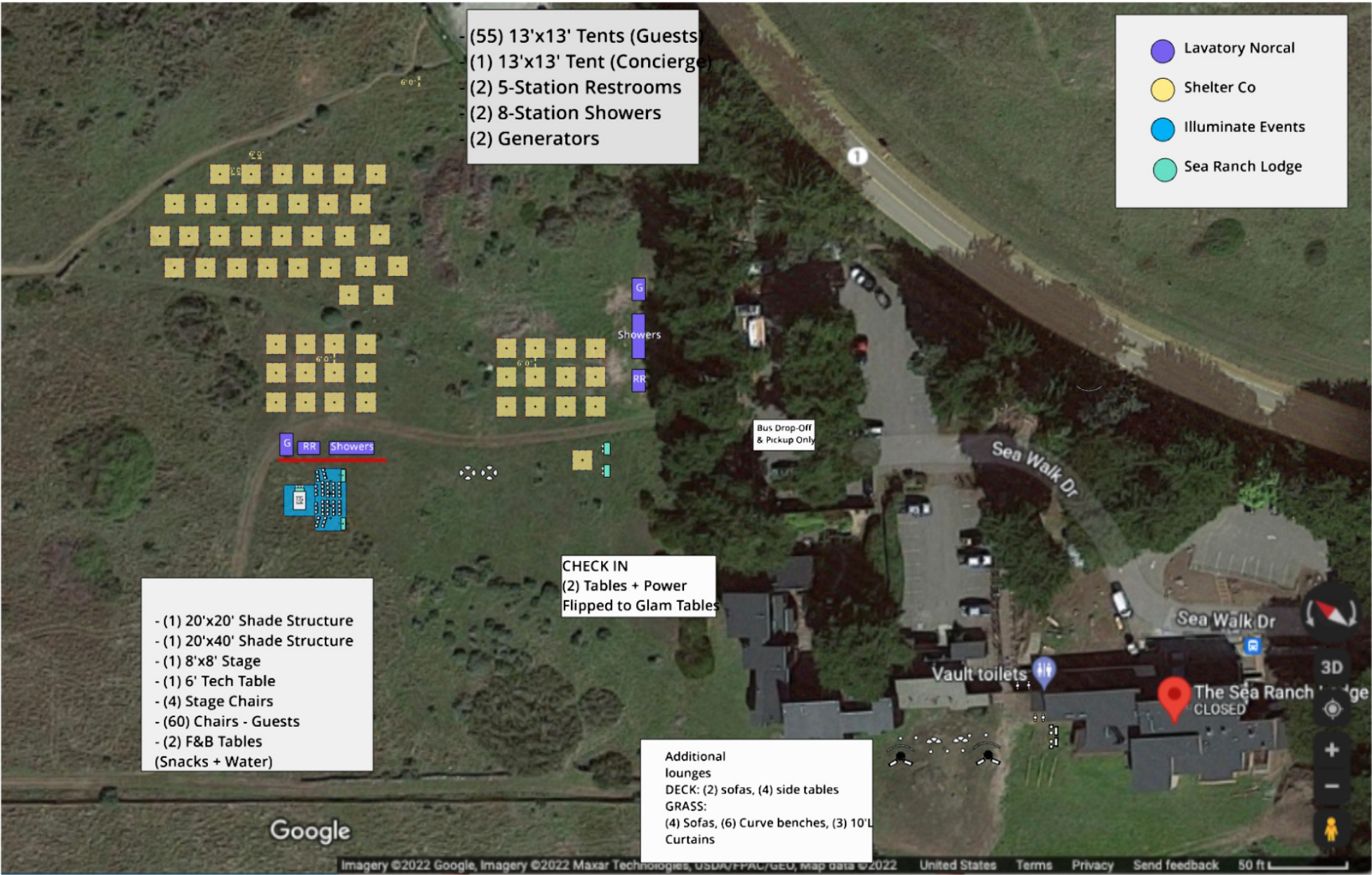




INDEMNIFICATION AGREEMENT





