

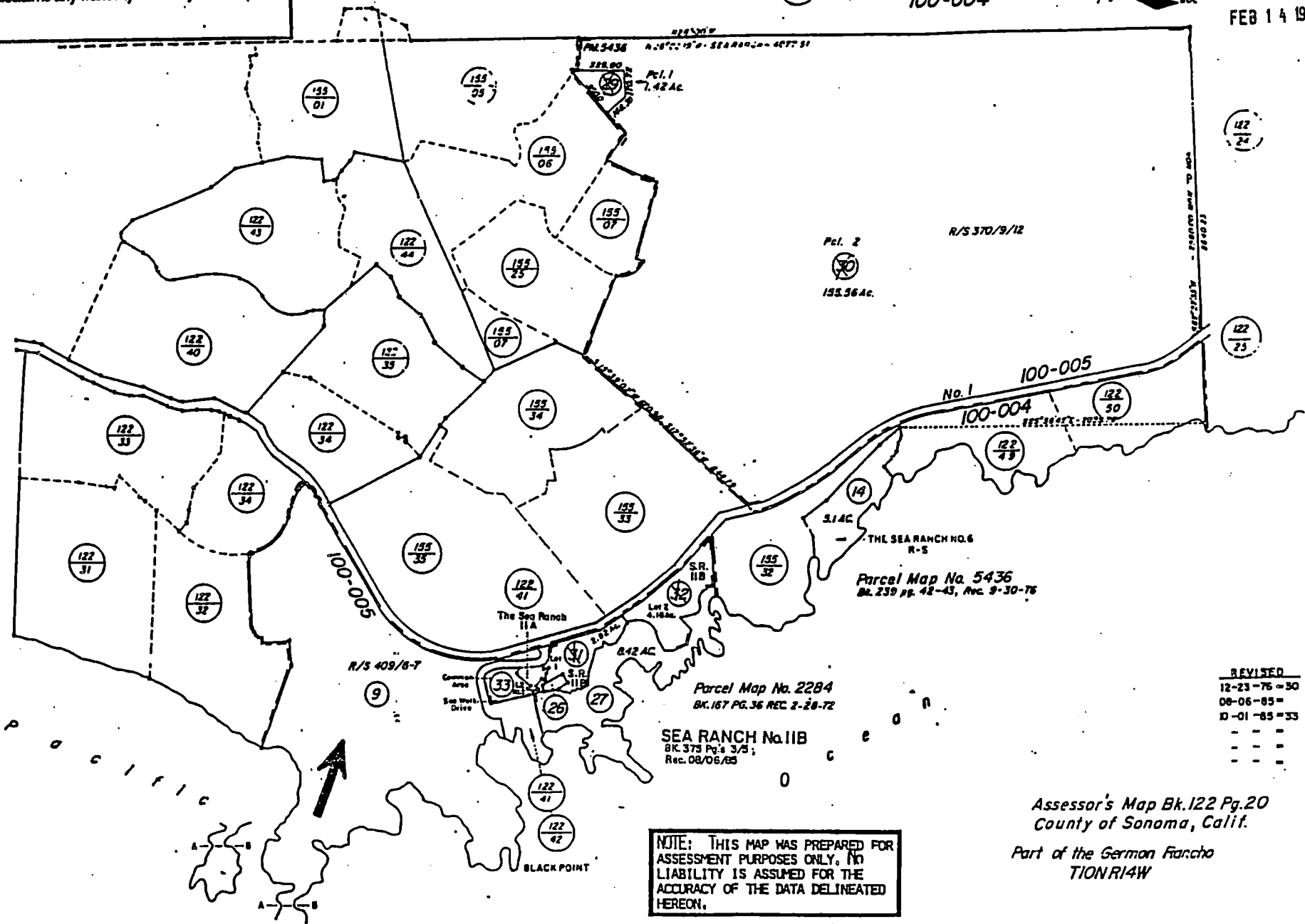

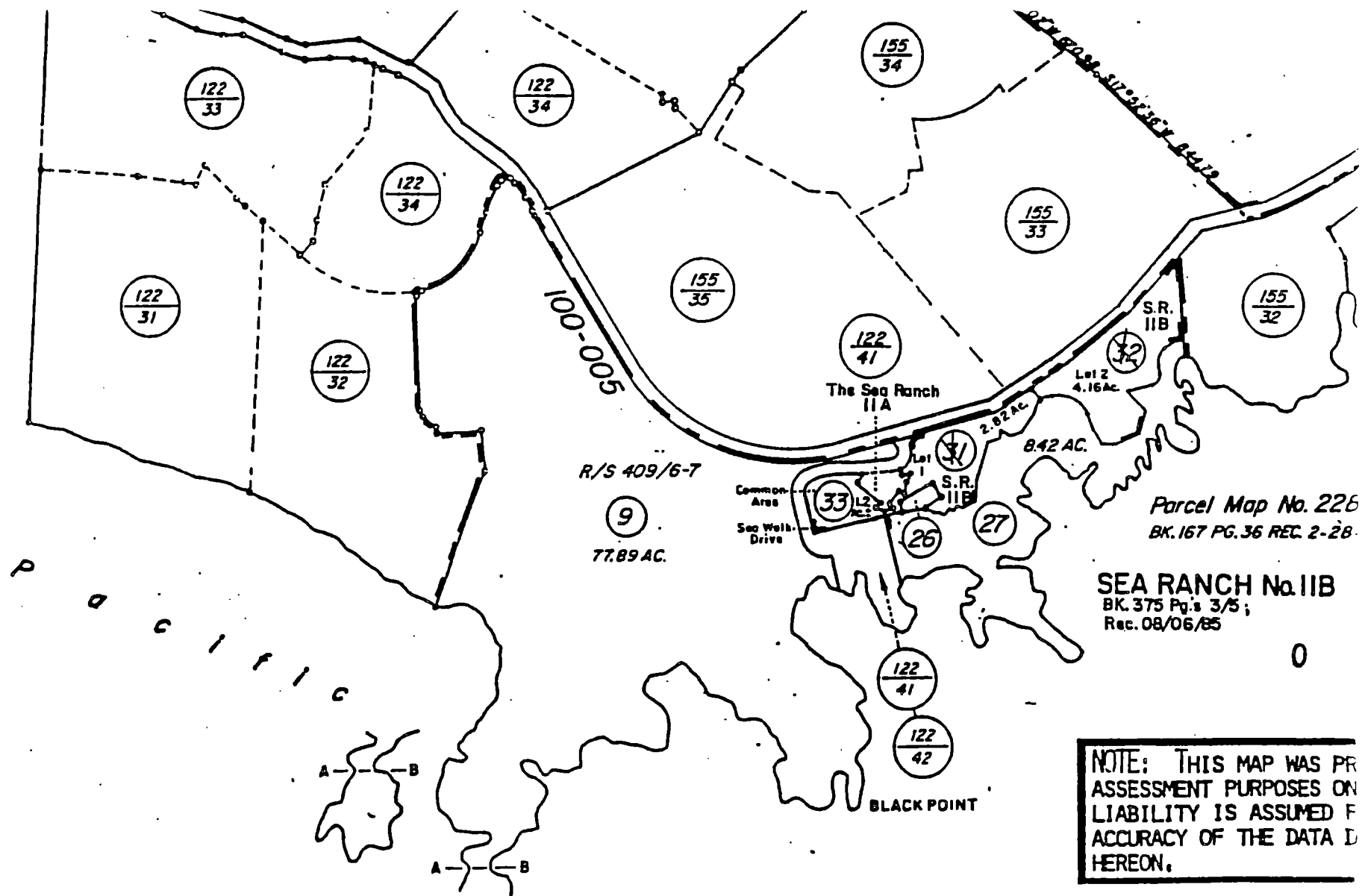

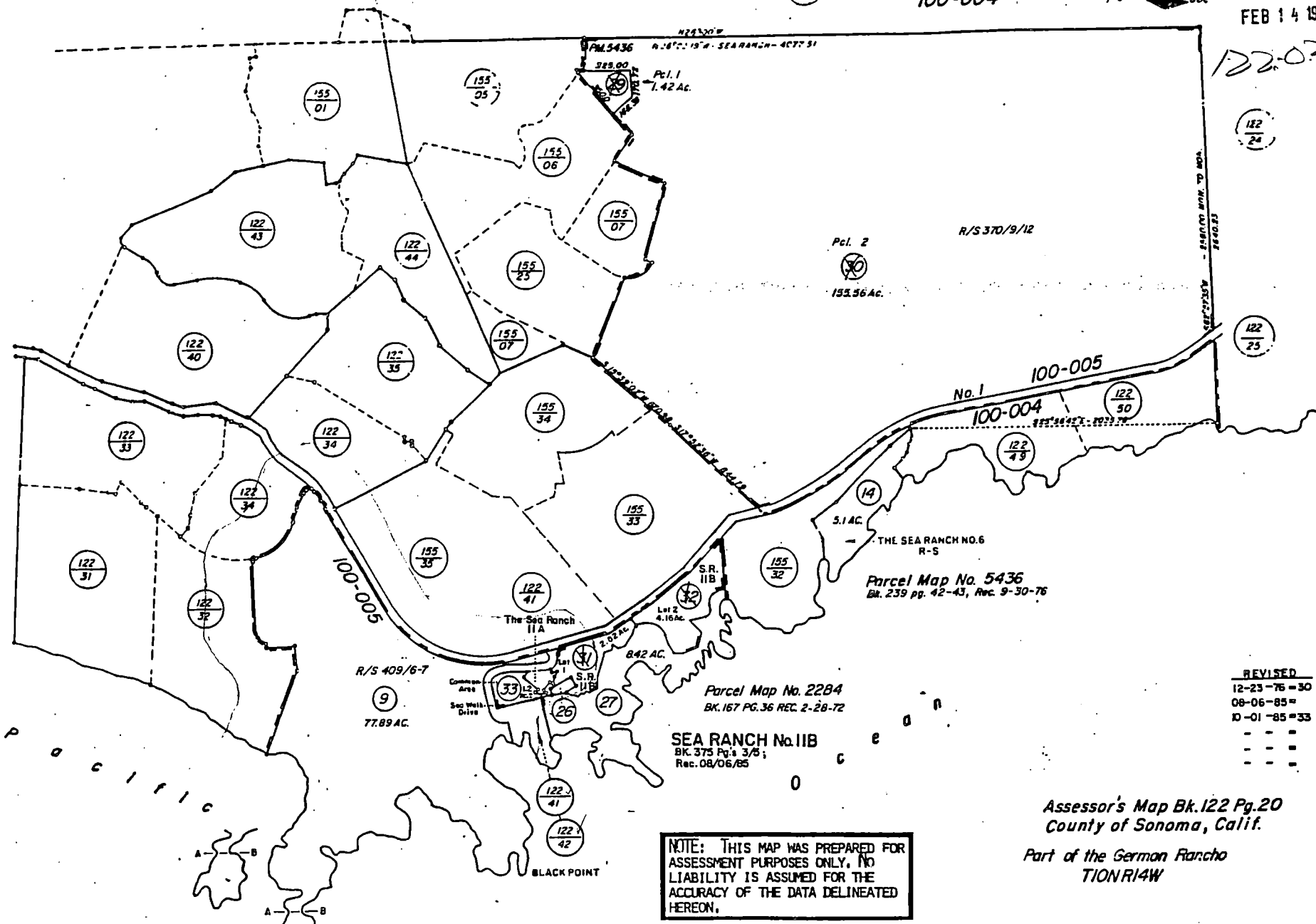
COUNTY ASSESSOR'S PARCEL MAP (122/21)

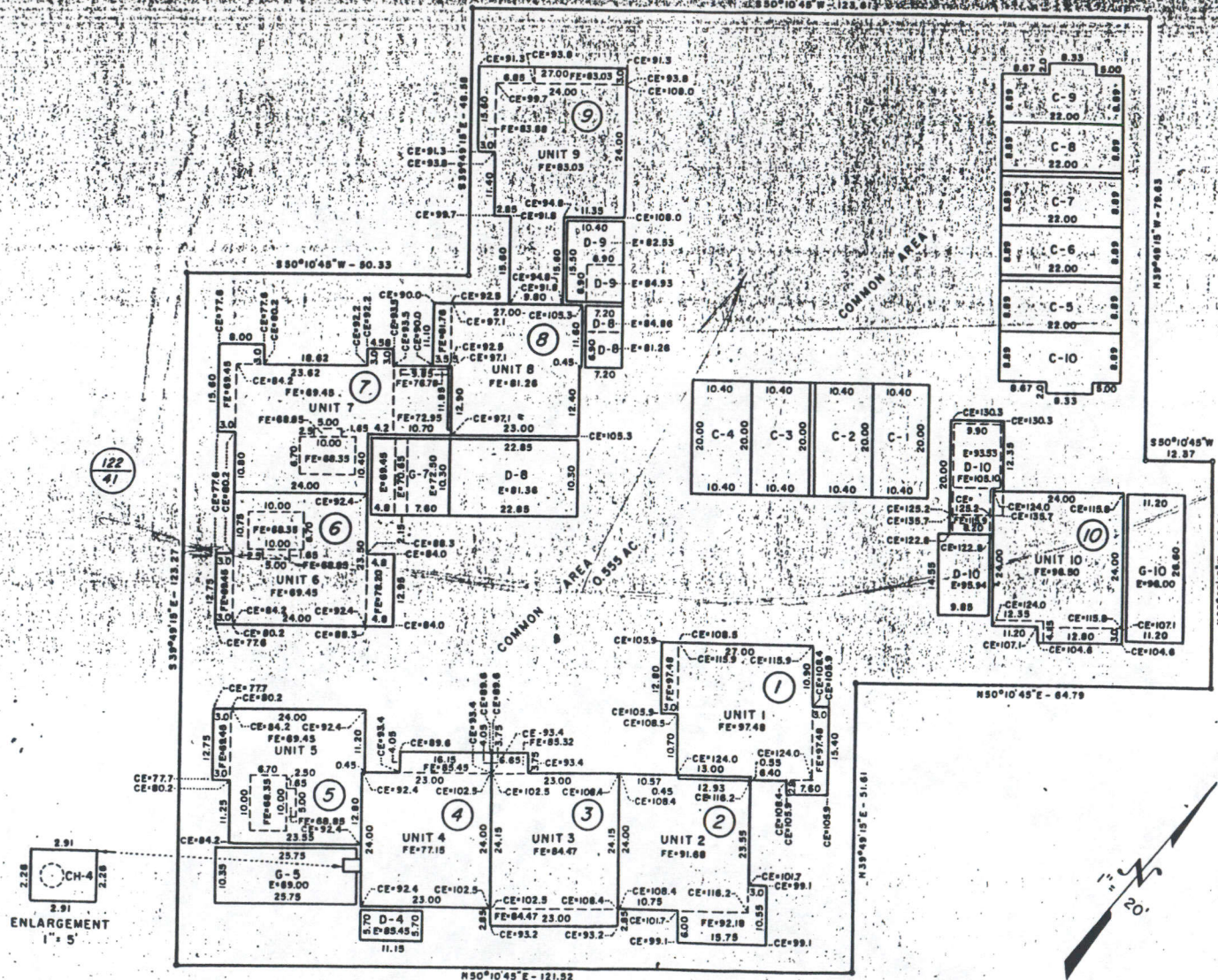
