Hi Jody. Here's what the code says on the wall surface:

CA Title 24, Section 1115B.3.2.5. Interior surfaces. In other than dwelling units, toilet room floors shall have a smooth, hard, nonabsorbent surface such as Portland cement, concrete, ceramic tile or other approved material

which extends upward onto the walls at least 5 inches (127 mm). Walls within water closet compartments and walls within 24 inches (610 mm) of the front and sides of urinals shall be similarly finished to a height of 48 inches (1219 mm) and, except for structural elements, the aterials used in such walls shall be a type which is not adversely affected by moisture.

Dear Mr. Starnes; Well, I guess we have our answer about routing out the pocket door frame to accommodate a raised circle/triangle. As Jody James states below, the pocket frame has metal edges and cannot be routed without destroying the integrity of the frame.

May we now request an exception based upon an unreasonable hardship? Our equivalent facilitation would be that tactile information will be provided on the wall in raised letters and Braille.

Since the passage of the ADAAG, persons with no vision are accustomed to finding tactile information on the wall beside a door. They do not seek tactile information on the door itself, for obvious safety reasons. Raised letters and Braille tactile information on the wall beside the door, centered at 60 inches AFF has become such a standard since the early 90's, that redundant tactile information on the door itself is not useful.

Thank again for your consideration. We look forward to your response.

I want respond as I believe a little more clarification is needed. With respect to signage, based on the fact that you may be able to notch the door jamb to accommodate the compliant signage thickness, you would not be able to claim a hardship unless this cannot be done without reconstructing the pocket wall. So I would first determine whether or not this relatively simple solution can physically be done. If you determine that option is not feasible or possible, then tell me so and I will approve the alternative based on a hardship, but I think you really need to take that first step in making that determination. With respect to the raised letters, I read the code a little differently. Section 1115B.6 Identification Symbols states in part; "Doorways leading to sanitary facilities shall be identified by a geometric symbol in compliance with this section. Geometric symbols shall be centered horizontally on the door at a heightr of 60 inches" There is an additional reference at the end of this section referring the reader to Section 1117B.5.1 for additional signage requirements and further reference to Section 1117B.5.5 Raised characters and pictorial symbol signs where the 1/32 inch is specified. The logical progression of these code sections do not differentiate between wall or door symbols. If you are able to show me a specific code reference to your claim, I would be more than happy to stand corrected. As I indicated, the color of the sign can be different from the standard blue & white, but must be "light on dark or dark on light" and be color contrasting with the door and wall.

For the walls, the plexiglass conforming to the dimensional requirements of the code will meet the code for smooth and hard surface.

For the floor, I am trying to give you guidance without researching an alternate material such as the polyurethane (which I didn't evaluate because the current floor does not meet the intent of the code, so I wasn't going to waste time and the Club's money on researching further). To the extent that you can conform to the code, coving up the wall with a material specified in the code 6 inches onto the wall, that would be great. If you are placing a smooth sheet of some sort to the wood which can be coved up the wall, this may well meet the intent of the code. Again, let me know what your plan will be and I may be able to approve the material without charging the fee. The fee would only be charged if I can't readily make an evaluation without researching the proposed material or method. I hope this has provided better clarification.

Thank you for your extensive and thoughtful reply, DeWayne. We very much appreciate your time and efforts to assist us.

I would like to confirm, then, what it is we will do to be in accord with your review:

Signage: For the circles and triangles on the pocket door, we will provide a tactile demarcation that is less than the 1/2 inch that would ordinarily occur when a 1/4 inch triangle is imposed on a 1/4 inch circle. To be clear, we will NOT be providing raised letters and Braille on the circle/triangle. Raised letters and Braille are required only on the wall beside the door. The circle/triangle will be in different color contrast to the door, which will be white.

The raised letter and Braille signs on the wall on the latch side of the doors will be ordered from the company specs which we provided for your review. They were items 6 and 7. They will be in white with the raised letters and symbols in brown.

Walls: For two feet around the toilet in the accessible unisex restroom, we will place sheets of plexiglass 48 inches high. The plexiglass will extend two feet beyond the toilet on the back wall, and to the door opening on the side wall.

Floors: We will either pay the \$306 fee and request a review of various materials that we can apply to the wooden floors, or we will cover the wooden floors in the unisex restrooms with vinyl or other materials that will cover the floor and cove up on the walls 6 inches. The floor in the waiting area will remain wooden, as it is not in a restroom.

Your response to confirm would be most helpful. If we do not receive a response, we will assume you agree and that in the interest of saving time are not responding.




