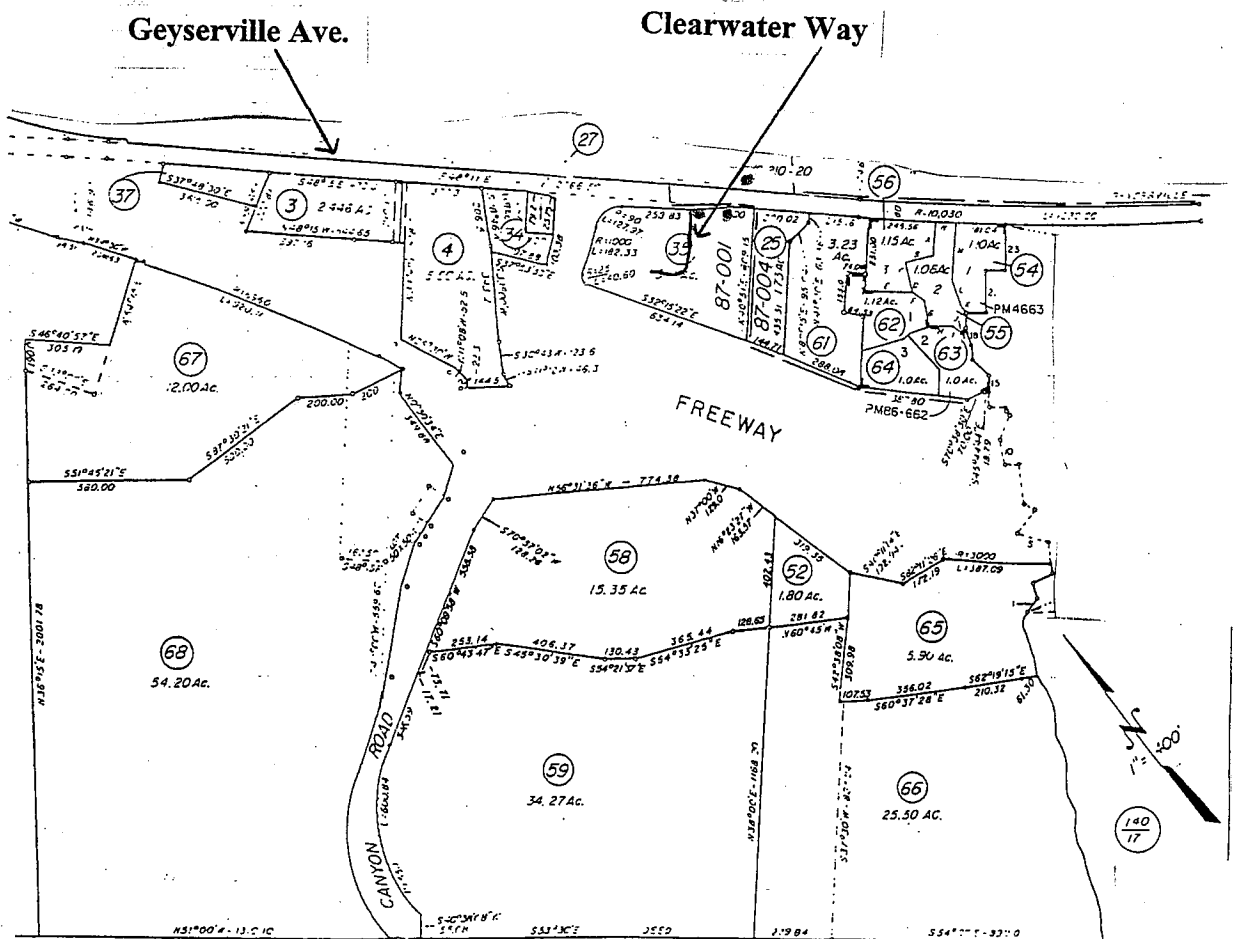
Sonoma County Ordinance # 4905 requires that private roads be named and that the Permit and Resource Management Department shall identify a road name that complies with the requirement of Section XIII of the Road Naming and Addressing Procedures and Standards for Applications made by Private Parties on Roads in the Unincorporated area of Sonoma County and formally approve the road name.

The Sonoma County Permit and Resource Management Department has received application RNC98-0010 requesting to name the existing unnamed road Clearwater Way. Such Road Name was approved on June 26, 1998.

The decision of the Permit and Resource Management Department on the road name shall become final and effective ten (10) days after the date of the road name approval unless an appeal is filed in writing with the Permit and Resource Management Department pursuant to Section 13-12 of the Sonoma County Code.

The Permit and Resource Management Department shall notify all affected property owners ten (10) days after the date of road name approval.
